SINA also publishes a newsletter & maintains a web site to further advise about the services we provide and the results of our efforts. SINA sometimes provides services, such as accounting or fiduciary assistance to other organizations and our employees and board members often serve as members for other organizations such as Neighborhood Revitalization Zone planning committees.

(Recognition, Education, Achievement and Community Health) committee annual banquet at which the Neighborhood Service Awards are presented honoring individuals for their efforts in the improvement of the SINA neighborhood, neighborhood safety programs including facilitating the integration of efforts by the security teams at our member institutions and the Hartford Police and neighborhood cleanup events, donations to the Hartford Police including equipment, sponsorship of Hartford Schools Science Fair where we provide for certain expenses as well as assist in providing volunteer judges for the childrens' projects, employment programs designed to facilitate employment of neighborhood residents at the SINA institutions providing walk to work employment.

The homes are located in our target neighborhood. Eventually when these houses are sold, at less than cost, to the buyers they have the effect of increasing home ownership rates and the stability of the neighborhood. Additionally the purchasers should qualify as members of the charitable classes served by the hospitals also. In any case all expenditures are related to our mission of support as designed by our supported organizations. The above actions all help in bringing about economic vitality and improving the quality of life in the target neighborhood.
